From 101: take Cactus Exit west about two miles NE corner of turn right into Cactus Park Scottsdale, Arizona

**Course:** Eight lane, outdoor, 25 yard pool with non-turbulent lane dividers. Colorado start and semi-automatic timing system with 2 buttons and 8-lane time display board will be used. A separate 25-yard warm-up pool will be available for continuous warm-up throughout the meet.

**Eligibility:**

1. Open to any USA Swimming athlete holding a current USA Swimming registration card as of the meet entry deadline. No on-deck registration will be available.
2. All swimmers, coaches, and officials must be registered prior to the competition and present proof of current registration to the Clerk of Course, if requested. All coaches and officials shall wear their current USA Swimming registration in a visible manner.
3. Swimmer's age on October 7, 2006 will govern for this meet.
4. Swimmers cannot swim any events in which they exceed the listed time standards (USAS BB).
5. Relays have no time standard (NTS).
6. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the Meet Director as to the need for any special accommodations or seeding arrangements

**Rules:**

1. The current USA Swimming rules of competitive swimming will govern.
2. This will be a timed final meet.
3. Relay entries for Sessions are due to the Clerk of Course 30 minutes after the start of the session.
4. Entry times must be the swimmer's best SHORT COURSE times. Swimmers that do not have a time in an event should be entered at No Time (NT).
8. All swimmers are limited to FOUR (4) individual events and ONE (1) relay.
9. The Arizona controlled meet warm-up will be posted and enforced.
10. No Time Trials will be offered during this meet.

**Entries:** Entries must be on enclosed Arizona Swimming Entry Form or a COMMLINK file. All other entries will be rejected. Teams are encouraged to submit team entries in a COMMLINK file by e-mail or floppy disk. Teams sending Electronic entries must submit a HARD COPY with a single team payment prior to the start of the meet.

**Entries must be received by Monday, October 2, 2006.**

Late entries will be accepted subject to a \$5 late fee depending on lane availability up to 30 minutes prior to the start of each session. No new heats will be created nor will any event be reseeded to accommodate late entries. Fees must accompany entries and are non-refundable. Entries without payment will not be accepted. **There will be a meet cap of 200 athletes to control size and timeline of the meet.** Teams whose entries are not accepted will be informed by e-mail and telephone as soon as practical.
